About the Italian Welfare League

Celebrating its 98th anniversary, the Italian Welfare League has gone from helping Italian immigrants on the New York piers find jobs and housing to its present mission of helping children of Italian-American descent who are ill or have suffered an emotional trauma. We call these youngsters "I Nostri Bambini," and have adopted them into our organization of caring members and supporters.

The League has donated more than \$1.9 million to more than 1,500 children and given grants to several organizations which provide services to children. Some of our recipients are children with Smith-Lemli-Opitz Syndrome, Autism, Asperger's Syndrome, Down Syndrome, brain injury and Epidermolysis Bullosa. Others have cancer, Cerebral Palsy, Multiple Sclerosis, terminal skin disease, or are accident victims. Some of our recipients have lost a parent under tragic circumstances.

The League's mission is to lend a helping hand to those in need within "la Famiglia".
